- c) The bidder whose bid is accepted will be notified of the award of the contract by the purchaser prior to expiration of the quotation validity period.


The terms of the accepted offer shall be incorporated in the purchase order.

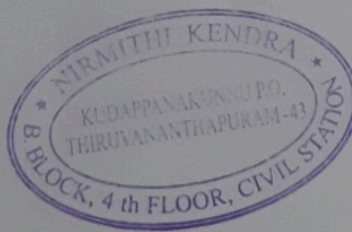
