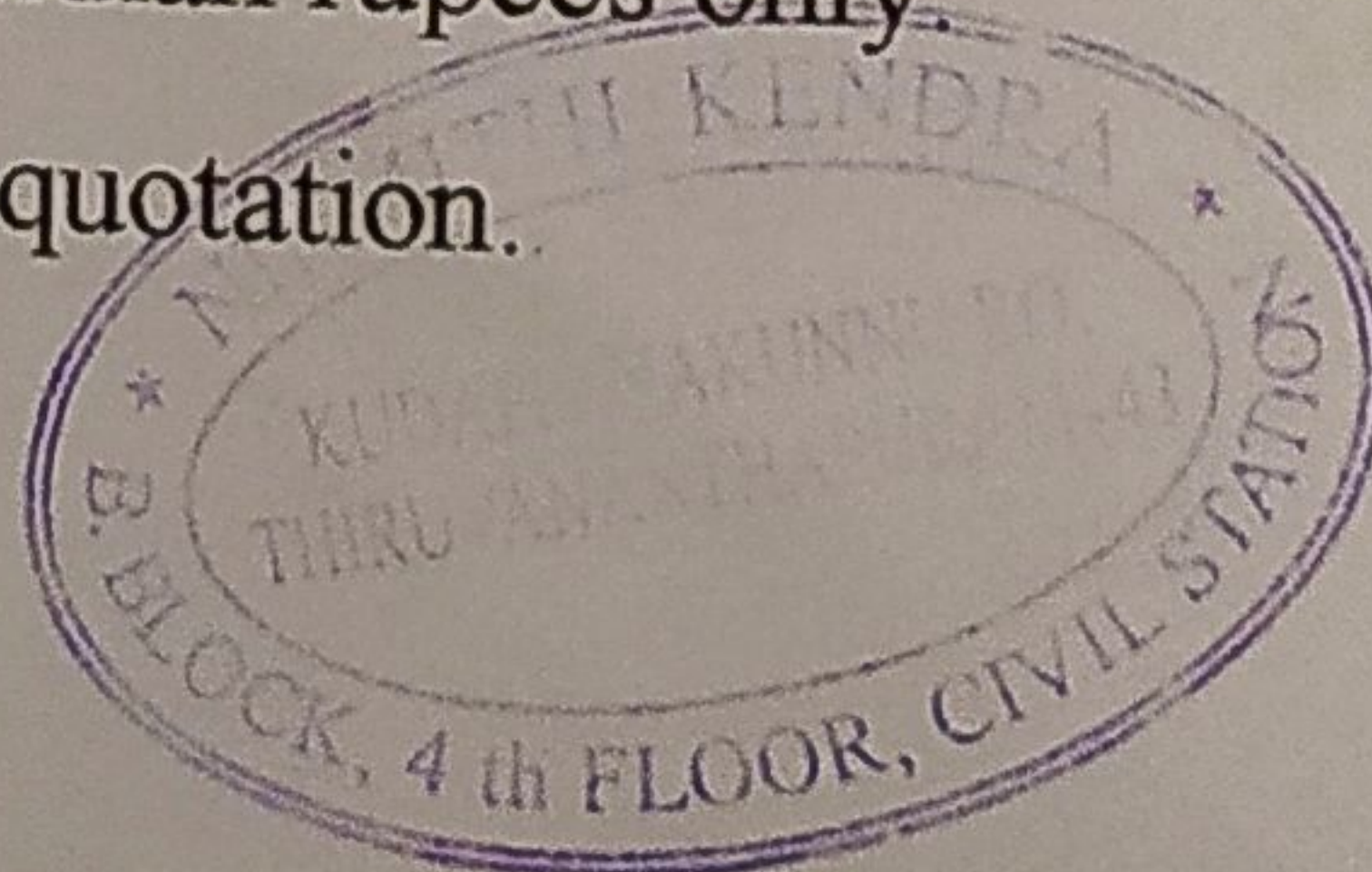

lowest evaluated quotation price

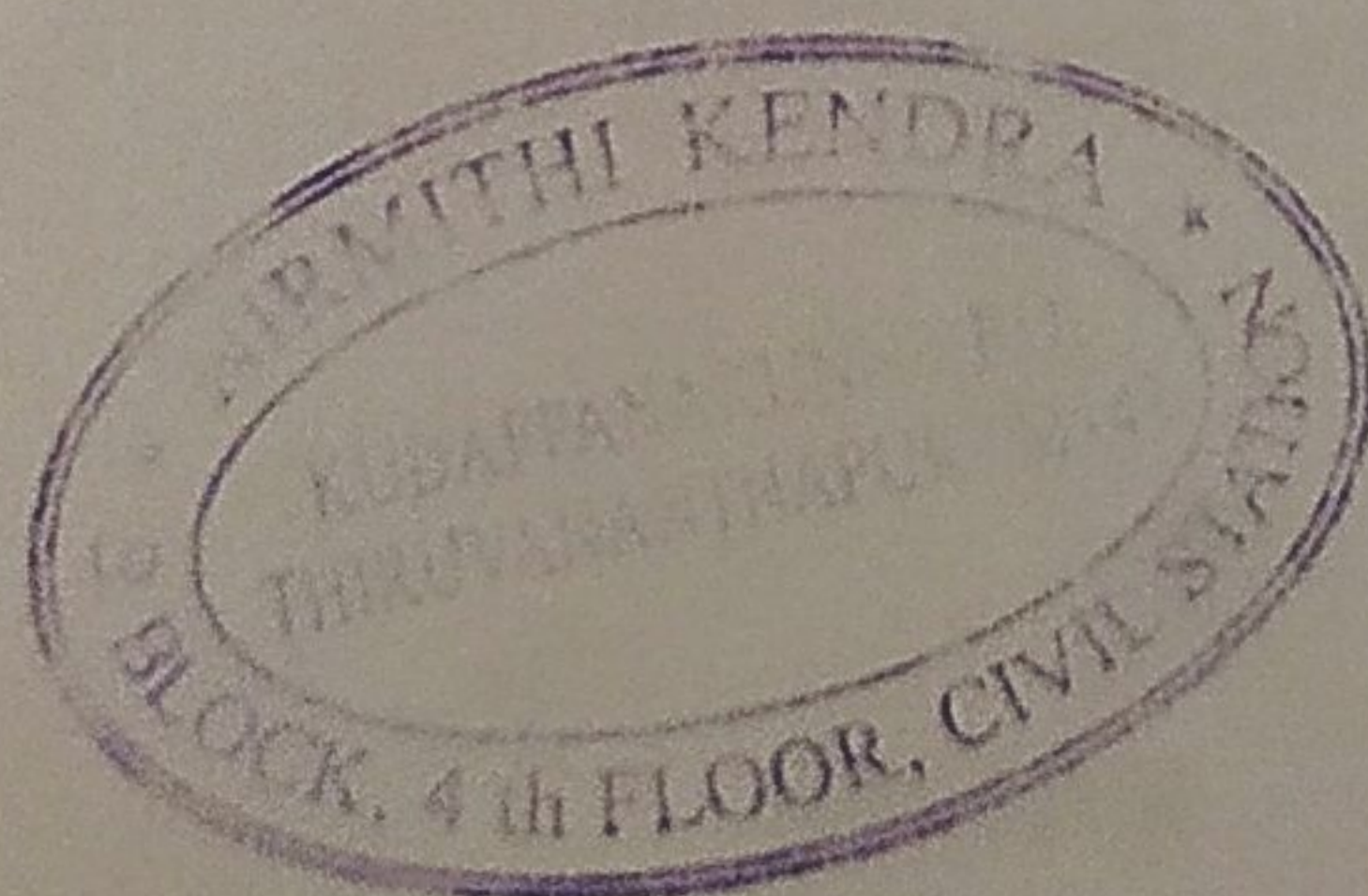


