

5) Evaluation of quotation

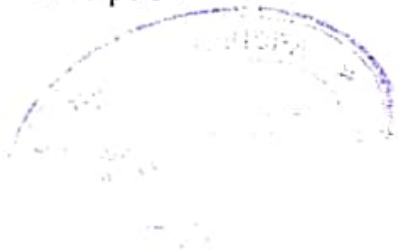
The purchaser will evaluate and compare the quotations determined to be substantially responsive ie which

7) The amount will be released after verification of the material in physical ,quality and receipt of invoice in this office according to the availability of funds. Individual or



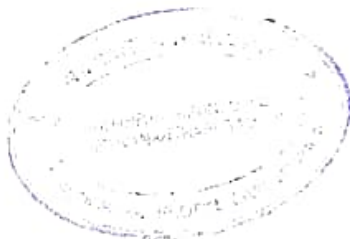
