


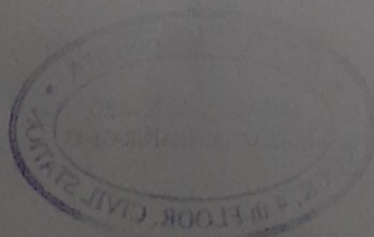
- a) Are properly signed
