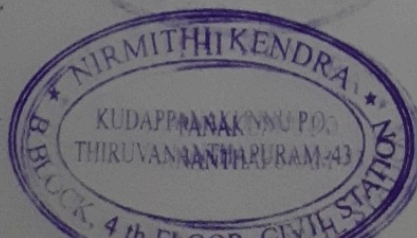

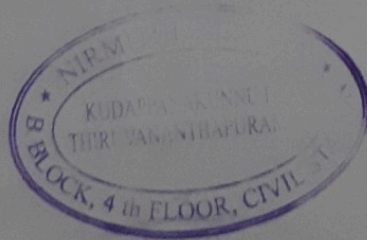
2) Bid Price

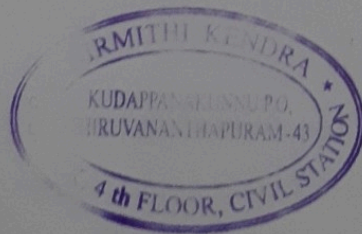
